I/we hereby release, discharge, and agree not to take adverse legal action against Banana Shire Council or its employees or contractors for any injury, death, or damage to or loss of personal property or income arising out of, or in connection with, my/our participation in the acquisition of shredded green waste /timber from a Banana Shire Council Waste Facility.

In consideration for being permitted to acquire delivered shredded green waste/timber from a Banana Shire Council Waste Facility, I/we hereby agree, for myself, my heirs, administrators, executors and assignees, to indemnify Banana Shire Council from any and all claims, demands, actions, or adverse legal action arising out of or in connection with my/our participation in the acquisition of green waste/timber from a Banana Shire Council Waste Facility.

I acknowledge and agree that I/we:

1. Am over the age of 18
2. Own or have legal tenure including a lease of Crown, State, Local Government or privately owned land and have sought prior approval for the delivery of shredded green waste/timber onto such land
3. Am a ratepayer and /or resident of Banana Shire Council area
4. Acknowledge that Banana Shire Council neither assures the quality, weed and seed status or bio security compliance of delivered shredded green waste/timber
