Council will consider your application and may choose to refuse or approve your application subject to conditions which may include cost of extending sewer connections, payment of head-works, etc.</p> <p>Where Sewer By Agreement is approved the applicant will be required to meet costs of installation of, and all associated work and will be responsible for ongoing maintenance and repairs of the sewer service line on the property side of the jump up.</p>
